

# Non-exclusive copyright assignment contract for a contribution to a periodical

## Preamble

The Journal publishes a periodical entitled *Journal of Interdisciplinary methodologies and issues in Science* (JIMIS), ISSN 2430-3038, hereinafter referred to as the "Periodical", and has entrusted Episciences with its distribution.

The Author has proposed an article, provisionally entitled:

(hereinafter referred to as the "Contribution") to the Journal for publication in the Periodical.

At the time of submission to the Journal, the Author has guaranteed that he hasn't proposed this Contribution for publication in any other publication or that he has interrupted the review process of this Contribution that he had proposed for publication in another publication.

# Definitions

"The final version of the manuscript accepted for publication" is the version whose content has been scientifically validated and edited (standardised, harmonised and structured).

The "Publisher PDF" is the final version of the manuscript accepted for publication after formatting by the Publisher.

## Art. 1 – Subject-matter of the contract

The Author transfers to the Journal, on a non-exclusive basis, the rights to use his/her Contribution in digital form. All the authors of an article must sign this non-exclusive assignment contract.

## Art. 2 - Author's obligations

The Author undertakes to submit to the Journal his final and complete Contribution, carefully proofread and edited in accordance with the Editorial Recommendations provided to the Author or accessible online on the Journal's website.

The Author guarantees that this Contribution is original and not already published by another publisher. If the Contribution contains extracts of text or illustrations borrowed from other works, the Author will provide the Journal with all the necessary reproduction authorisations for publication purposes.

The Author also guarantees that his Contribution contains nothing that falls within the scope of the law that could incur the Journal's liability, and guarantees to the Journal full use of the assigned rights against any interferences, claims and evictions whatsoever.

## Art. 3 – Assignment of digital use rights

The Author also assigns to the Journal the right to use the Contribution in digital form, and in particular:

- to reproduce the Contribution in the Periodical or separately, as well as its translations, in the form of electronic files in all existing or future formats such as HTML, XML, PDF, ePub, on all current or future digital recording media such as Internet servers, USB keys, hard drives, memory cards, tablets, computers, e-readers, mobile phones, electronic paper or e-paper, enabling digital data to be stored temporarily or permanently;
- to represent its Contribution in the Periodical or separately, as well as its translations, to enable it to be communicated to the public, free of charge or subject to a charge per unit or by subscription, by any current or future processes, in particular via the Internet and via the networks of any legal entities under public or private law such as companies, libraries, educational and research establishments, with a view to consulting the Contribution online and downloading it via a remote or local computer connection;

- to adapt the Contribution and its translations in the form of a multimedia work or to integrate it into a multimedia work, to reproduce it on any medium and to represent it by any of the processes indicated above.

The Author also authorises the Journal to distribute his Contribution in open access under the Creative Commons CC BY licence, for all the use modes and media mentioned above, which means that any interested person will have the right to re-use all or part of his Contribution without having to ask for his consent, under the following conditions: obligation to name the Author (BY).

In view of the mission of disseminating research knowledge and results, which is the purpose of the publication of the Contribution (Education Code, article L. 123.6), and in accordance with article L. 122-7 of the Intellectual Property Code, the Author expressly agrees to assign these rights to the Journal free of charge.

This assignment free of charge to the Journal is made on a non-exclusive basis, in all languages and in all countries, for the duration of the literary and artistic property right according to French and foreign laws and current and future international conventions, including any extensions that may be made to this duration and by all current or future processes.

The Journal may exercise these rights itself or by transferring them to third parties; in this case, it undertakes to inform the Author. Similarly, as the assignment is made on a non-exclusive basis, the Author may also subsequently publish his Contribution with another publisher, provided that the full bibliographical reference of the first publication in JIMIS is mentioned.

## **Art. 4 - Obligations of the Journal**

The Journal undertakes to publish the accepted Contribution in the Periodical, within a maximum period of *12 months from the date of its submission* to the journal.

Prior to publication, the Journal shall ensure that the Contribution meets the requirements of an academic publication and provides it with editorial added value (spelling and typographical checks, bibliography check and standardisation, structuring, checking and processing of iconography).

## **Art. 5 - Policy for inclusion in open archives**

Since the Author transfers his rights to the Journal on a non-exclusive basis, he is free to place the final version of the manuscript accepted for publication of his Contribution in an open archive under the CC licence of his choice, as soon as he wishes, including as soon as the Contribution is published in the Periodical.

Academic social networks (such as ResearchGate or Academia.edu) are not open archives: contributions must be deposited in an open archive, in particular for reasons of durability, with a possible link to this open archive from the academic social networks.

The Journal authorizes the author to place the Publisher PDF in an open archive (a permanent platform that can be consulted by all without prior registration), as soon as the contribution is published in the periodical.

The Journal requires the author to affix a CC BY license, in accordance with its own open access distribution policy.

# Art. 6 - Applicable law and settlement of disputes

This contract is governed by French law. Any dispute that may arise in connection with this contract shall be submitted to conciliation prior to any recourse to the courts.
